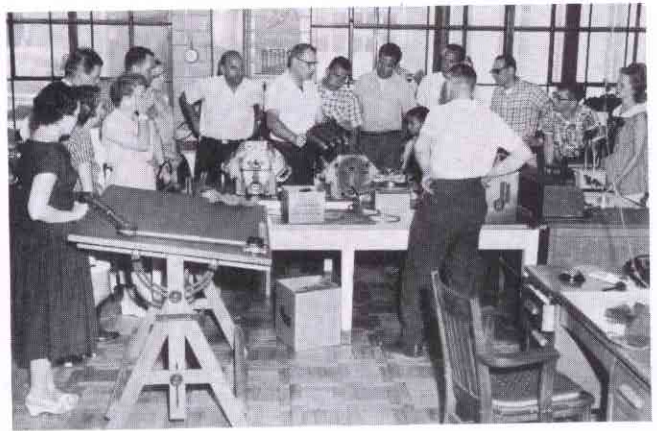






## ELKHART LAKE VISITED BY CHICAGO CORVETTE CLUB

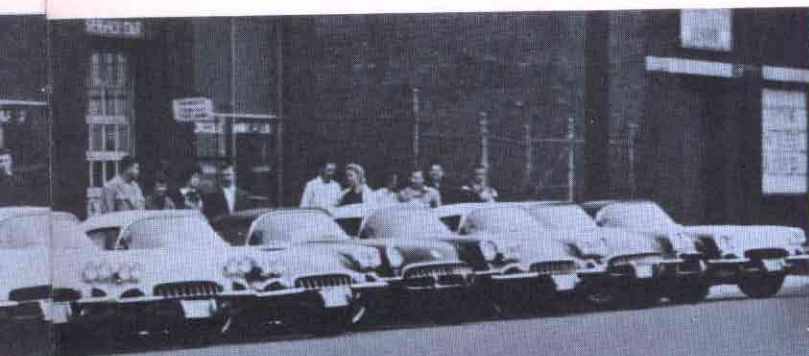


## NORTHEASTERN CORVETTE OWNERS' CLUB STAGES WEEKEND OUTING FOR MEMBERS
